Is your firm in line with what is happening around? You can find out by nominating your leaders for this Program.

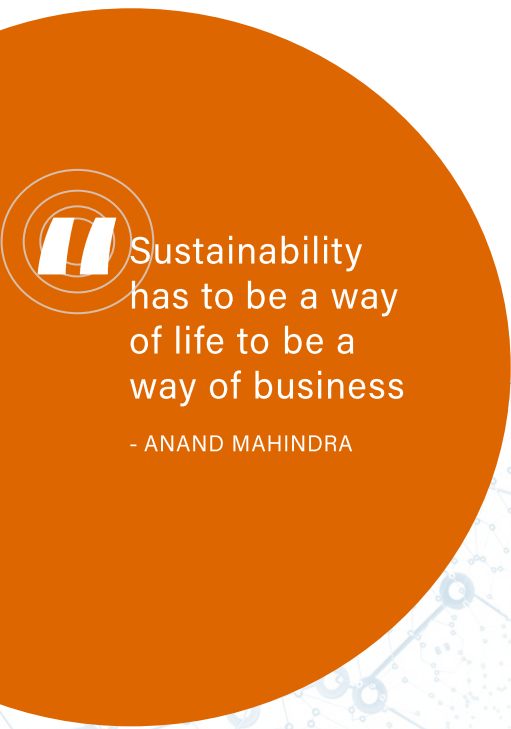
What the Program Offers:
